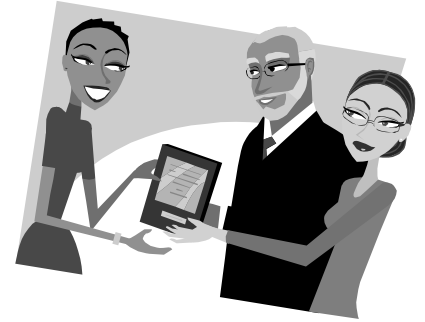

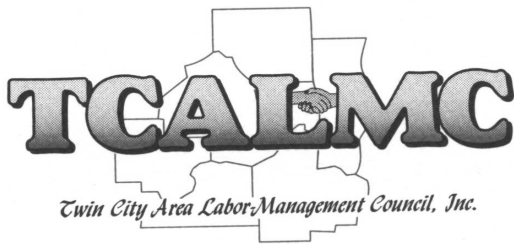

Directions to IUOE Local 49,
2829 Anthony Lane South, Minneapolis

From the North: Take 35W south. Take exit 24 toward Co. Rd.- C (.2 miles). Turn left onto Long Lake Rd. (.1 miles). Turn right onto Co. Rd.- C west (.7 miles). Turn left onto Anthony Lane South continue left.. End at 2829 Anthony Lane S.

From the South: Take 35W North. Take Cleveland Ave./ Co. Rd – C exit #24 (.1miles). Take Westbound Ramp(.2 miles). Merge onto Co. Rd. – C west(.9 miles). Turn left onto Anthony Lane South and continue to the left. End at 2829 Anthony Lane S.

From the East: Take MN Highway 36 West. Merge onto 35W north toward Cleveland Ave. (.8 miles). Take Cleveland Ave./ Co. Rd – C exit #24 (.1miles). Take Westbound Ramp(.2 miles). Merge onto Co. Rd. – C west (.9 miles). Turn left onto Anthony Lane South and continue to the left. End at 2829 Anthony Lane S.

From the West: Take 394 East. Merge onto 94 east through the Lowry Tunnel. Merge onto 35W north via exit 233C on left (6.5 miles). Take Cleveland Ave./ Co. Rd – C exit #24 (.1miles). Take Westbound Ramp (.2 miles). Merge onto Co. Rd. – C west (.9 miles). Turn left onto Anthony Lane South and continue to the left. End at 2829 Anthony Lane S.
